






PROGRAMS

Fostering Leadership, Advancing Representation

CHCI welcomed 29 talented young Latino professionals as its 2023-2024 Public Policy and Postgraduate Fellows cohort, including 10 emerging Latino leaders with graduate degrees who immersed themselves further in the public policy fields of education, housing, international affairs, environmental innovation, health, child welfare, law, technology, and finance.

Participants gained important insights into the national public policy arena and are completing placements both on and off Capitol Hill during the program.

CONGRESSIONAL INTERNSHIP PROGRAM

Gaining Legislative Experience

The CHCI Congressional Internship Program equips participants with legislative knowledge, cultural competency, professional development and leadership skills. In 2023, these 10-to-12 week programs successfully provided in-person programming to 63 undergraduate students from across the country. The program immersed participants in the public policy process, facilitated meetings with accomplished Latino leaders, broadened professional networks, and inspired our young leaders to become more engaged community members.



My experience as a CHCI Intern was one of professional and personal growth. NEXTGEN LATINO LEADERSHIP PROGRAM

Fostering Civic Engagement and Lifelong Advocacy

In 2023, CHCI hosted its 13th annual NextGen program in Washington D.C. The program took place over three distinct one-week sessions: June 11-16, July 9-14, & July 23-28, 2023. The 121 young people who participated in the program represented all geographic regions across the United States. The young people came from 24 states, as well as Puerto Rico and Washington D.C., and represented 15 different Hispanic heritages. The average participant GPA was 3.93.





Many of us come from communities where we don't see Latinos in positions of influence. This program teaches us that we can take on those positions and initiate change in our community. Visiting D.C. and meeting influential Latino leaders makes me feel like I can be heard and that I can one day be in those influential positions as well."




