In a world adjusting to a new post-pandemic normal, CHCI remained committed to our mission of developing the next generation of Latino leaders. 2022 marked the return of our in-person events and programming, as well as the launch for the debut of our Run to Lead 5K Day. After nearly two years, we were thrilled to be able to once again gather with our community in person!

More than 40 years after our founding, the relevance of the CHCI mission still rings true. In 1978, four visionary members of the Congressional Hispanic Caucus (CHC) established an organization to foster a fresh wave of Hispanic leaders. These emerging leaders would have the power to transform our nation through public service in Congress and other spheres. With each passing year, our work takes on greater significance and makes an even more profound impact. We take immense pride in all we have accomplished and we are grateful to have so many partners join us on this remarkable journey.

The pages of this annual report demonstrate the extraordinary year that was 2022 for CHCI.

It was a testament, and a celebration of, the past, present, and future contributions of Latinos to this great nation. It was this understanding that drove our purpose and provided a pathway to success.

Over the course of the year, we had the privilege of engaging 178 program participants representing 29 states and Puerto Rico. They came to Washington, D.C. and experienced the magic of Capitol Hill firsthand via internships, fellowships, and leadership experiences. We've drawn inspiration from the exceptional young leaders who joined us. With their graduation from our nationally heralded leadership development programs, CHCI expanded our network to nearly 4,800 alumni.

In addition to implementing our outstanding leadership development programs, 2022 also saw us build on our practice of convening leaders from the public, private, and nonprofit sectors to discuss issues that are important to the Latino community. We held 14 events that attracted more than 4,000 attendees. During these events we sparked dynamic conversations, connected with

Members of Congress and leaders from across all sectors, and provided a platform for the exploration of solutions to critical issues.

CHCI's success is made possible by the steadfast engagement of members of the Congressional Hispanic Caucus, other Members of Congress, and the generosity of our supporters and partners. Equally, the achievements of this year were advanced through the commitment of the CHCI Board of Directors, Advisory Council, accomplished alumni and dedicated staff. I am profoundly grateful for the opportunity to be a part of this incredible team and look forward to the road ahead in fulfilling our mission of developing the next generation of Latino leaders.

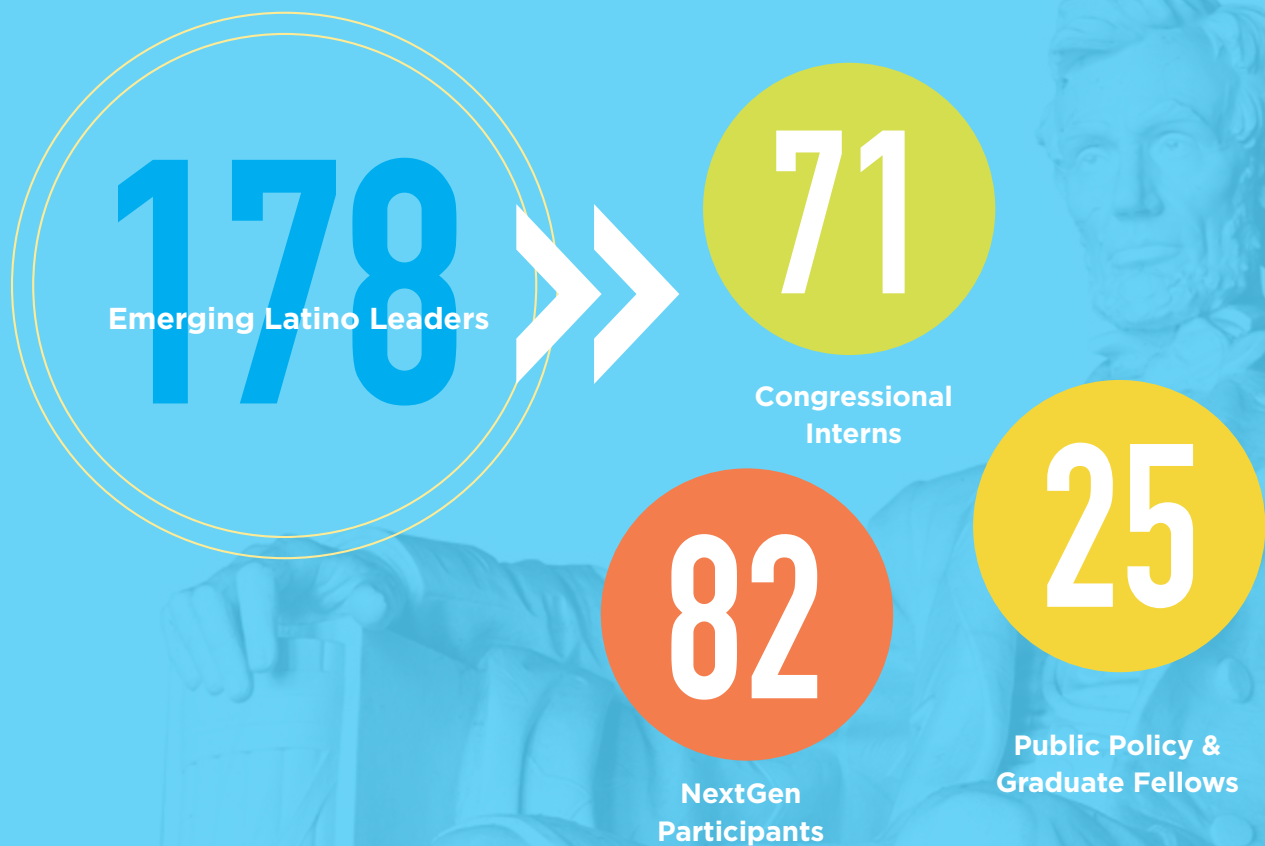

Gaining Legislative Experience

CHCI's Congressional Internship Program (CIP) equips participants with legislative knowledge, cultural competency, professional and leadership skills. In 2022, the 10 to 12-week programs successfully provided in-person programming to 71 undergraduate students from across the country. Our program experience included the opportunity to immerse themselves in the public policy process, meet accomplished Latino leaders, build their professional network, and become more engaged community members.

Sparkling Civic Engagement

CHCI hosted its 12th annual NextGen program in person in Washington, D.C. for the first time in two years. The program took place over three different one-week sessions: June 12-17, July 10-15, and July 24-29, 2022. The 82 exceptional young people who participated in the program represented all geographic regions across the United States. This consisted of a total of 17 states as well as Puerto Rico and Washington D.C. representing 14 different Hispanic heritages. Together, they averaged a perfect 4.0 GPA and more than half demonstrated financial need.



I think it is important for NextGen to exist because young Latino leaders need this type of empowerment. Many of us come from communities where we don't see Latinos in positions of influence. 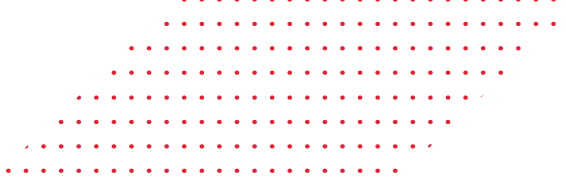

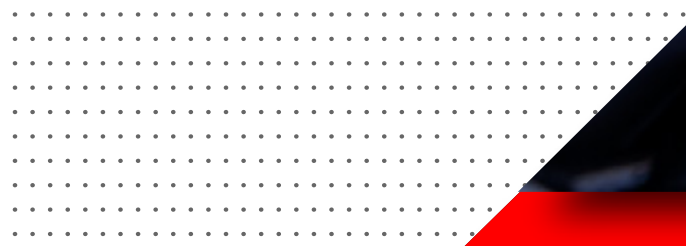
